

Remark: Interviews on position "Financial Services" are taking place from May to November, 2012.

Job title: Financial Services.

We are a perspective French company that collaborates with a lot of countries.

Due to our expansion we are recruiting regional managers in Europe.

Due to expansion of the international market this position is associated with working with database of clients and financial operations.

Within 2-3 days after the probationary period, we will send a contract to your postal address. After signing contract all the documents will be sent, and you will receive access to the corporate account of the company in your region as well. Employees are receiving money monthly so they have no contribution to VAT. Salary € 3,500 plus 4% of each transfer. You can also choose the way how you would like to be paid – we can send you salary to bank account or pay with bill check.
